PARK NEWS

QPARA Park Liaison, Clare Gillan

As usual the park team has been busy over the summer keeping our park beautifully maintained and running smoothly and events well attended – Shakespeare in the Squares, Kilburn State of Mind and the twice weekly Children's shows in August. Queen's Park also welcomed 3 new goats to the farm: Ivy, Vinnie & Bramble.

Since the end of the bird nesting season (end of September) the team has been trimming the perimeter and tennis court hedges. Work has been done to the older children's playground as parts of the hexagon tyre swing and the zip line have been out of action for some time. The large climbing frame known as the "Timber Tangle" is closed due to rotten timbers. Investigations will establish whether it will be repaired or removed. The bandstand has also had a new lick of paint.

Wildlife monitoring cameras are being regularly set up at night in the Woodland Walk to understand how this habitat is being used and how to enhance it in the future. Areas are being created to reduce footfall and ground compaction and to encourage plants to flourish.

In October applications closed for the Café which has been re-marketed by CofL. We await the outcome.




CHRISTMAS CAROLS

NEW FUNDING MODEL FOR OUR PARK

The City of London Corporation is undertaking a major reform of how its green space charities – including Queen's Park – are funded, aiming for greater financial resilience, transparency and operational flexibility. This overhaul, known as the Natural Environment Charities Review (NECR), is reshaping the way CofLC supports its parks, woodlands and open spaces across London.

Historically, much of the funding has come from their property investment income, notably through the City's Cash endowment, which underwrites many running costs. Individual charities then supplement their budgets through café rents, room hires, event fees etc. However, rising maintenance costs, inflation and increasing biodiversity demands have placed pressure on this model.

Under the NECR, CofLC is introducing a Grant Funding Model. Instead of automatic "deficit funding" from central resources, charities will receive a defined grant for local operations and will be allowed to retain any surpluses. This approach encourages greater financial autonomy and proactive income generation. From April 2026, Epping Forest and West Ham Park will adopt the new model. It will extend later to the North London open spaces.

Highgate Wood and Queen's Park are managed under a single registered charity. Their annual expenditure is monitored through quarterly reports. A new 5-year business plan will prioritise investment, revenue streams and long-term sustainability.

We are proud that a new splash pad is proposed to replace the disused paddling pool in Queen's Park, and QPARA is supporting the City in their fundraising goals. The budget is estimated to be £380,000 and is being met through local budgets and external funding.

The NECR involves a comprehensive asset audit, a strengthened governance framework, and a sharper focus on fundraising, grant bids and biodiversity-related income such as offset schemes. Consultants have been appointed to help build fundraising capacity, while policies will ensure that commercial activity remains consistent with each charity's mission. Importantly, public access will remain unrestricted.

POLICE

For the first time in many years the Queen's Park Ward Safer Neighbourhood Team (SNT) is at full strength. Sgt Ben Shearman has two Police Constables, PC Nelton Scott and PC Ayesshha Khann, and two PCSOs, Ferenc (Frank) Turcsanyi and Amandip Kaur.

SAFER NEIGHBOURHOODS

LOCAL POLICE, LOCAL KNOWLEDGE

The Ward Panel made up of residents and community representatives meets Officers every quarter to discuss crime hot spots and residents' concerns. Currently the hotspots are Salusbury and Chamberlayne Roads where there is a prevalence of thefts and anti-social behaviour. Interestingly, most crimes are reported on a Monday!

In the past three months there was an increase in crime across the Ward but this was primarily due to Carnival. There were 49 shoplifting incidents from June-September up from 36 in the same period last year and significantly up from 26 in April–June 2025.

Carnival issues aside, crime rates remain stable, except for car theft. Twenty-two vehicles were stolen in the past three months, almost double the number from the previous three months. Most thefts happen at night when the SNT are not patrolling. Their advice: use strong steering locks and report unusual behaviour. Gangs are scoping the area for up-market cars for parts and resale abroad.

RUSH HOUR TRAFFIC + MORE

QPARA Streetscape Co-ordinators

In May, we reported that consultants MP Smarter Travel had completed their work on traffic through the Queen's Park area for Brent Council. Their proposals did not gain support from either residents or the Council. QPARA's request urging the Council to "call in" the officers' report on MPST was rejected on legal grounds. Subsequently, without prior consultation, Brent combined the areas covered by the first and second Experimental Traffic Orders – southern and northern avenues respectively – into a single new Order.

This revised ETO, which came into effect on 8 May, restricts entry to the avenues from the west and north on weekdays between 7.30-9am. Brent's website states that a final decision on the scheme will be made after 8 November, six months after it began.



Unfortunately, no traffic monitoring was carried out beforehand. Monitoring strips were installed in September, but so far QPARA has not received results despite requests.

Given these uncertainties, we decided to seek members' views urgently. Working with QPARA officers, we designed an impartial survey of Full and Associate Members, conducted via Survey Monkey between 2-8 October. The impressive response rate was 42% from 539 members, higher among Full (resident) members. The overall finding from 224 respondents was that 45% said 'no' to making the ETO permanent with 35% saying 'yes' and 20% undecided, calling for more study. Support was strongest among residents within the designated area. Full results are on the QPARA website. The October QPARA meeting agreed to send the findings to Brent, urging that they be carefully reviewed and that the Council engage meaningfully with QPARA, neighbouring associations, and the wider public to find a broadly acceptable solution.

Meanwhile, QPARA continues to pursue related improvements. With London Assembly Member Krupesh Hirani and Ward councillors we are pressing TfL to introduce a right-turn filter from Harvist into Salusbury Road and over the station bridge. We also await progress on a school street at Chevening Road's east end. In May, councillors and local associations held a walkabout on Chamberlayne Road to review post-'Kensal Corridor Scheme' issues; Brent is now working through the resulting action checklist.

KENSAL CANALSIDE

The planning application process for the development on the old gasworks site, south of the canal, has reached an important stage. The Royal Borough of Kensington and Chelsea has announced that on 11 November 2025 the planning meeting will consider "Project Flourish" (Ballymore & Sainsbury's) application. The first stage application for the other development, "Kensal Gasworks" (Berkeley, St William) has been submitted.

These are both "Hybrid" applications which means that detail is only provided for the first phase to be built, other parts are only outlined. In the case of the Ballymore application, there is detail only for the new Sainsbury's store itself. Subsequent applications will provide further details, but they may differ from the provisional information.

QPARA has made objections at both stages of the Ballymore application and to the St William application. Our main concern is the effect on traffic locally. The only vehicle access to the site is from Ladbroke Grove, which is already frequently congested. While it is proposed to close the petrol station, the applications show an overall increase in vehicles accessing the site. This single access could be compromised by local roadworks and will complicate emergency access.

We have also raised concerns about heavy lorries during the construction phases, potential release of contaminated materials from the site, the low amount of "affordable housing", the overwhelming visual impact of so many tall buildings clustered together and disruption to the memorial to the 31 victims of the 1999 rail crash.

If permission is granted, construction will take at least 10 years, most likely longer.

KENSAL GREEN CEMETERY

Kensal Green Cemetery, opened in 1832, was the first of the "Magnificent Seven" commercial cemeteries in London which addressed chronic overcrowding in church graveyards. It is the only one of those seven to still be run by the original company, the General Cemetery Company (GCC).

It provides a final resting place for many famous and significant people, as well as royalty, including writers such as Thackeray, Trollope and Wilkie Collins; scientists and engineers Babbage, Marc and Isambard Brunel, Joseph Locke, Charles Siemens and Charles Wheatstone; artists and illustrators such as John Leech, Daniel Maclise and John Tenniel.

The crematorium opened in 1939 and many well-known people have been cremated here including Douglas Bader, Ingrid Bergman, Christine Keeler, Freddie Mercury, Alan Rickman and Mel Smith.

While the crematorium ensures a steady income, it's not enough to maintain the cemetery buildings. In particular the Grade 1 listed Anglican Chapel needs millions of pounds for restoration. It was thought that the Kensal Canalside Development might be a source of money but that has not turned out to be the case. Individual memorials are the responsibility of each family, not the GCC.

As a commercial organisation, the GCC is ineligible for lottery and similar funding and is, under the terms of the 1832 Act of Parliament, unable to transfer ownership, so a bill is currently going through Parliament to enable transfer of ownership of the cemetery to a charity and the first stages of setting up such a charity are underway.
